
Report on the Korean trial fishing on walleye pollock in the Convention area of the Bering Sea in 2003.

The trial fishing in the convention area of the Bering Sea (Donut hole) was conducted two times by Korean commercial fishing vessel in 2003. First, it was conducted by Korean stern trawler, her name is MAN JECK NO. 21 (tonnage 2,800.93 G/T), in the Convention area during 12 days (Mar. 12 \sim Mar. 23, 2003). Second, O YANG HO - 2 (tonnage 3,527 G/T) of stern trawler conducted in the Convention area during 15 days (Mar. 12 \sim Mar. 26, 2003). The main purpose of the trial fishing was to determine the geographical distribution of walleye pollock in the Convention area and to collect biological data of walleye pollock. But walleye pollock was caught 2 fish (2.6kg) only during Korean trial fishing in 2003.

Fig. 1 and Fig. 2 were presented the hydroacoustic tracklines and haul positions during first time and second time.

First time conducted 6 hauls using the midwater trawl net of Green Netex 800 (codend mesh size 110mm). The depth of trawl gear was 30m to 180m, the hauling time was 6 hour to 22 hour. In haul no. 1, some fish caught; salmon 5 fish (1.731kg) and smooth lumpsucker 88 fish (76.2kg). Haul no. 2 were caught 118 fish (118.9kg) of smooth lumpsucker, 5 fish (2.0kg) of salmon, 1 fish (0.2kg) of rock sucker and 44 fish (2.4kg) of decapod. Haul no. 3 were caught 16 fish (13.6kg) of smooth lumpsucker, 12 fish (4.1kg) of salmon, and 1 fish (1.2kg) of walleye pollock. Haul no. 4 were caught 104 fish (59.6kg) of smooth lumpsucker, 20 fish (12.5kg) of decapod and 400 fish (29.3kg) of harchet fish. Haul no. 5 were caught 320 fish (210.0kg) of smooth lumpsucker and 190 fish (17.0kg) of hatchet fish. Haul no. 6 were caught 250 fish (265.0kg) of smooth lumpsucker and 12 fish (9.0kg) of salmon (Table 1, 2).
